Under no circumstances should you upload a completed form if you are in any doubt whatsoever about whether you have sufficient funds for your fees and living costs.

- 1. I have read the 'Your financial condition' section of <u>A quide to your offer and its conditions</u>, the fees and living costs sections of the <u>Terms of Admission</u>. And, where relevant, the guidance provided on <u>costs of arrival</u> in Cambridge from overseas.
- 2. I confirm that, making due allowance for annual increases (at least in line with inflation) and for currency fluctuations where relevant, I have the funds available to me to meet all my University Composition Fees and living costs ('maintenance') for the whole period of my studies at the University of Cambridge. I have calculated my estimated minimum financial undertaking above.
- 3. I understand the <u>restrictions on taking paid work</u> while I am studying full-time at Cambridge. Full-time students must not expect to provide additional income in this way.
- 4. I understand that the University or my College may request to see evidence of my ability to meet my minimum financial undertaking, and pre-payment of fees and charges may be required in advance at any point of my course.
- 5. I confirm that should my funding circumstances change before I matriculate, I will notify the University and, if relevant, upload an updated financial undertaking form AND (if applicable) official notification of new awards to my self-service account.
- 6. For staff fee applicant only: I understand that, if I am a member of staff of the University

- receiving the benefit of concessionary University fees and my employment contract ends before my studies, I will be liable to pay the full rate of fees for the remainder of my studies.
- 7. I understand that failure to provide accurate and honest information about my financial situation will be treated seriously by the University and/or my College and may lead to the cancellation of my admission. It will also preclude me from accessing College or University hardship funding.

Notes

Powers: Chapter I of the University's Ordinances stipulates that students are required to pay the University Composition Fee for their course. The power to withdraw students for non-payment of fees is set out in paragraph 12 of <u>Chapter VII of the Ordinances</u>. Your College may decline to present you for conferment of a degree if you have outstanding debt to your College.
